

Information on the processing of personal data of a participant in a scientific study

According to Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter “GDPR”), the Jagiellonian University informs that:

1. **The administrator of your personal data** is Jagiellonian University, 24 Gołębia Street, 31-007 Kraków, represented by the Rector of the Jagiellonian University.
2. **Jagiellonian University has appointed a Data Protection Supervisor**, 4 Czapskich St., 31-110 Kraków, room no. 27. The Supervisor can be contacted by e-mail: iod@uj.edu.pl or at telephone number 12 663 12 25.
3. Your personal data will be processed for:
 - recruitment process of the scientific study entitled “Mapping study of navigation services and structures for cancer patients across the EU and beyond”;
 - sharing with members of the research group;
 - archiving;
 - compliance with legal and regulatory requirements, including requirements for sharing data with regulatory agencies overseeing the study;
 - confirmation of the proper conduct of the study and the integrity of the research **based on** written consent in accordance with Article 6 (1) (a) and Article 9 (2), (a) GDPR;
4. Your provision of personal data is voluntary, but is a condition for participation in the above mentioned study. **The consequences of not providing personal data** will be: not being able to participate in interviews on navigation services and structures.
5. Your personal data **will not be transferred to the third countries (outside the European Economic Area)/international organizations**.
6. Your personal data will be **processed for a period of 10 years** from the date of completion of the *EU NAVIGATE scientific study “Implementation and evaluation of a Navigation Intervention for People with Cancer in Old Age and their Family Caregivers: an international pragmatic randomized controlled trial”* for archiving purposes for the period provided by the law.
7. You have **the right to**: obtain information about the processing of your personal data and your rights under the GDPR, access to and rectification of the content of your data, and the right to have your personal data deleted from the controller's files (unless further processing is necessary for the performance of a legal obligation or to establish, assert or defend claims), and the right to restrict processing, data portability, object to processing - in the cases and under the conditions set forth in the GDPR.
8. You also have the **right to withdraw your consent** at any time without affecting the legality of the processing carried out on the basis of the consent before its withdrawal. 9. **The consequence of withdrawing consent** to the processing of personal data will be the gate of opportunity to participate in the EU NAVIGATE research study *“Implementation and evaluation of a Navigation Intervention for People with Cancer in Old Age and their Family Caregivers: an international pragmatic randomized controlled trial”*.
10. Your personal data will not be subject to automated decision-making or profiling.
11. You have the right to lodge a complaint with the President of the Personal Data Protection Office if you find that the processing of your personal data violates the provisions of the GDPR.
